### B. MATTERS OF GENERAL INTEREST

1. <u>Projections of Cost Changes to Tiers as PEPRA Membership Grows</u> Educational presentation by the actuary

Mr. Wickman introduced actuary Graham Schmidt of Cheiron. Mr. Schmidt presented information regarding Projections of Cost Changes as PEPRA Membership Grows. The presentation was originally scheduled for the October 2016 Strategic Workshop. Mr. Schmidt explained the process of examining how PEPRA membership impacts the Plan costs and overall populations now and as projected into the future. The analysis begins by calculating the differences in the Normal cost rate for PEPRA members versus the population they are replacing.

Trustee Shaw joined the meeting at 9:03 a.m.

Mr. Schmidt reviewed the differences in the total Normal Cost, average member rate and employer Normal Cost for legacy and PEPRA members. For PEPRA members rates are generally lower because the benefit is lower. For example, as of July 1, 2016 the total Normal cost rate for Marin County Miscellaneous Classic members is 19.61% as compared with 17.62% for PEPRA members. The Employer Normal Cost for these two groups is 1.82% lower for the PEPRA members. Mr. Schmidt stated the lower average cost for PEPRA members means that the average Normal cost will decline slowly over time. Mr. Schmidt attributed the fact that County employees' average member rates were slightly more than half the Normal Cost where the result of labor negotiations that provided for additional employee contributions to pay for enhanced member benefits. He noted that the largest differences in legacy versus PEPRA average member rates are for Safety members in the City of San Rafael and Southern Marin Fire District. As a result these entities have a larger decline in the employer contribution rate.

In response to Trustee Cooper's inquiry on other factors affecting Normal Cost for PEPRA members, Mr. Schmidt explained that retirement benefit calculation of 3 years of average final pay remains the same. Mr. Wickman added that PEPRA did not prescribe the Cost of Living Adjustment (COLA) and therefore some employers have a 4% COLA for their PEPRA members.

The projection of levels of non-PEPRA and PEPRA members for MCERA as a whole shows PEPRA membership increasing from 17% in 2015 to about one-half in the next five years. All projections assume a level active workforce. As of June 30, 2016 the actual PEPRA membership was close to the projected 23%. Mr. Schmidt discussed similar statistics for each employer valuation groups.

In conclusion Mr. Schmidt observed that the Experience Study to be completed in 2017 may affect these projections. He further stated that the Normal Cost for smaller employer groups will stabilize as PEPRA membership expands over time. Responding to Trustee Piombo's inquiry, he explained that a 25 basis point reduction in the assumed rate of return would be expected to lead to a 4 to 5% increase in the Normal Cost.

# 1. Administrator's Report

### a. Administrator's Update

Retirement Administrator Jeff Wickman said Mr. Schmidt will present preliminary June 30, 2016 actuarial valuation results at the February Board meeting. The schedule is to approve the final valuation report in March.

Mr. Wickman reported that Marin County is beginning its budget process for fiscal year 2018-2019. The County is anticipating potential changes in the retirement contribution rates as a result of future changes in the economic assumptions that may come from this year's tri-annual Experience Study.

Mr. Wickman attended the Marin County Association of Retired Employees (MCARE) luncheon at San Rafael Joe's. Trustees Gladstern and Jones were also in attendance. Mr. Wickman discussed the overall financial position of the retirement plan and discussed ways that MCERA can assist with providing information to retirees about MCARE.
